

# Our mission is to enhance the quality of Life in Ashtabula County.









We began this mission in 1959 to raise funds to respond to the growing social and recreational needs of our community.

Our first major project in 1959 was to raise the funds to build the Ashtabula YMCA. This project costed \$740,000 and was opened to the public in 1960.

In order to save money, and to efficiently utilize our donors dollars, CDC conducts a campaign only once every 5 years.

In 1965, CDC kicked off its 2nd campaign to raise matching funds to build the Kent State University Ashtabula Campus. Then in 1970, raised the money to build the Ashtabula Arts Center.

The last eleven campaigns have resulted in caring, community-minded donors funding through CDC over 20 million dollars to complete over 200 projects. CDC's grants have also brought in matching funds from other state, federal, and philanthropic sources to increase the total value of funded projects from 20 million to over 25 million dollars.

#### OUR MISSION

"The Civic Development Corporation of Ashtabula County is an organization that provides leadership in addressing and planning for the needs of Ashtabula County by identifying as its strategic goals certain development programs, capital projects and initiatives, which will improve the quality of life in the county; and providing the fundraising, organization, financial experiences and oversight to attain these goals."

## **ABOUT THE SURVEY**

The Civic Development Corporation Community Assessment Survey was distributed to donors, donees, and other members of the Ashtabula County community in Fall 2018. The survey collected 173 responses by: direct communication, email, social media, print and word of mouth. We had a great diversity in responses by age, educational background, and industry.

The survey participants recognized Ashtabula County as rich in many natural resources. Participants indicated they would like to CDC continue to offer quality of life projects that put our children and families first, while making greatest use of Ashtabula County's abundant natural assets.


We heard that you want opportunities for families to enjoy the outdoors, but also a desire to continue a relationship connecting families with the arts.


As always, CDC will proudly deliver capital projects that not only benefit citizens, but help enrich business growth throughout the county.

Full grant applications are due June 1, 2019 and we are currently accepting letters of intent from interested parties.






















What do you feel is the best way for CDC to communicate our mission, current updates on projects, and send feedback from the community on future quality of life projects?






#### Age Range


#### Marital Status

#### How Many Years Have You Lived In Ashtabula County?






#### Highest Education Level Achieved
